A pool party consists of 6 or more swimming guests, which includes adults and children. If the number of guests is less than 6, the member may purchase guest passes.

\$45/hr for parties under 15 guests

\$50/hr for parties 15-30 guests

\$55/hr for parties over 30 guests

\*\$25 additional fee for private parties scheduled before or after regular pool hours
